WHAT IS GIFT AID?

Gift aid allows charities to reclaim the tax paid on a donation at no cost to the individual.

WHY SHOULD I GIFT AID MY DONATION?

By completing this gift aid declaration form Hope House Children's Hospices can increase your donation by 25% at no extra cost to you.

WHO CAN GIFT AID?

To qualify for gift aid, you must pay at least the same amount of Income Tax or Capital Gains Tax in one tax year (6 April one year to 5 April in the next) as we claim on your gift (currently 25p for each pound you donate).
